- 4) Treasurer: Tom C. nominated Rich N. for Treasurer, Edie J. seconded. Tom moved to close the nominations, motion carried. Rich N. was elected to serve as Treasurer of the FCUAC.

**Police Report:** Deputy Jeff Harmon provided his monthly police report.

**Guest Speaker:** Julia Larson, Rural Economic Strategy Coordinator, KCEO- Office of Business Relations and Economic Development.
