

Meeting called to order at 7:05. Volunteer to take notes on meeting tonight, Edie J.

Guests present- Deb Eberle, CARE organization.

Public Comment: none

Old business and reports

Bylaws, as introduced in the summer, were presented for final discussion and approval. Tom explained that the changes were for clean-up of articles 5 and 6, where many items were essentially restructured rather than being changed. Additional bylaw review is being conducted by the Executive Committee, and this current action will make the markup of the document easier going forward. Tom moved and Edie seconded adoption of the changes. All approved.

Tom said he'll do a Four Creeks Boundary review to see if changes are necessary because of annexations that have occurred. This includes voter counts and precinct analyses from a new voter list which he will secure.

Other activity:

He asked members to consider how we can push forward the agenda for transportation in the area. Tom will work on an Atlas map request from the community to show all the development plans in the area surrounding the Y intersection of 156th up to NE 4th where Four Creeks and the City of Renton share borders. This will include the Permitted or In-process of seeking permits or are being built. It appears that this kind of comprehensive information isn't being taken into consideration for the traffic impact they all could have.

Tom said he has access to a report the school did on the biology of May Creek which he will scan and send to members; that they are removing sediment in the creek and will be done soon; suggested WLRD should come out to do a Creek Report in the coming months.

Public Health notified us they want to go paperless with the EpiLog report of communicable diseases and such; Edie agreed to make contact and coordinate getting the info on e-mail to the Council.

General discussion;

Bette suggested we could address the parking situation that is on the Issaquah-Hobart Road by the landing zone for the paragliders. Issaquah is known nationwide for the sport, so something should be done to make the area better served for parking. Tom noted that same parking lot is the launch site for a massive trail network as well. Bette, Tom and Connie Marsh from Issaquah will get together to discuss this further

Bette also suggested we should stop spending money on food for NNO events, but maybe work on getting picnic tables and benches for community use. Or perhaps historical markers could be designed and placed in the area. With CSA grants due by December 8, perhaps these ideas could be used to frame a question for the DNRP folks, and see if we could get a grant to help them out.
